



HERE IS WHAT YOU NEED TO KNOW BEFORE CHECKING IN

What are Glamping Tents and how can we book this tents.

Glamping is a portmanteau of glamorous and camping and describes a style of camping with amenities and, in some cases, resort-style services not usually associated with "traditional" camping.

How can we book the tent?

You can email or Whatsapp to us for faster response. Alternatively, you may use the book online button(Only for tent booking). For direct booking, we will only secure the booking once we received the payment.

For direct booking what information do we need?

Please kindly let us know the date, how many pax and what event. We do have packages to choose from. Please let us know if you have book the pit.

What is the exact location of the Tent and the picnic?

The exact location will be at 1490 East Coast Parkway 468965. For Bbq pit booking, please kindly choose Area G BBQ For picnic you may choose other than ECP with additional Charges. Do note that places like Marina Barrage, Botanical Garden etc only allows simple picnic setup.

What is the check in and check out timing?

Check-in time will be 3pm onwards and check out time will be before 12 noon the next day. For picnic the duration will be 3hrs max. Additional hours will be charge.

Camping Permit

Please kindly book your camping permit on AXS online or download the AXS apps and make the booking. Please select Camping Area G. List down the name of the occupiers. Select additional days if you are checking out after 9am. For example if you are suppose to check on 15th, Please select 14th-16th. Permit should be place at the front of the tentage.

Tent Price Range

Our tent is from \$150 for a medium tent with one double bed. Maxi couple tent with two double beds at \$180. A big family tent at \$240 with 3 double beds and a Jumbo Tent at \$300 with 4 double beds.

What should we bring and what provided

Please kindly bring along shower essentials like towels and soap. Public toilet with shower facilities is nearby the camping site. Bring along your portable powerbank, extra clothing, food and drink(shop is faraway from camping site), insect repellent and other necessities which required.

Please take note, Love4picnic is not responsible for any loss or damages.

Please kindly take care of your own belonging. All tenant will received a number lock. Please kindly secure the tent the whole time. If the lock is missing, please kindly contact the host.

WHAT SHOULD WE DO IF RAINING?

Please kindly remain in the tent and open the window for ventilation. If it is thunderstorm, for your own safety, we advise to postpone to a later date. For picnic, the setup timing will be extended or postpone to another date if there is no progress.

Annex B

Dear campers

To cater to the popularity of this activity, the requirements for a camping permit application with effect from 30 June 2011 will be:

1. Applicant must be 16 years old and above,
2. A Permit Holder is only allowed one permit for one tent at one time. A new permit will only be issued after the expiry of an existing permit
3. Each applicant is limited to camping for four (4) days per month.
4. The permit must be prominently displayed outside the tent at all times.
5. NParks reserves the right to revoke the permit if the Permit Holder has not complied with the terms and conditions of the permit. NParks also reserves the right to bar the Permit Holder from future permit applications.

Things to Note

By clicking the "I Agree" button, I have read and understood the terms and conditions of the Camping Permit ("Permit") as stated below:

As a Permit Holder, I hereby undertake and agree that:

1. I shall adhere to the permit duration from 9am on the day of the permit to 9am the following day. The Permit is non-transferrable.
2. I shall provide the particulars of all occupants of the tents during the validity period of the permit, at the time of my application for the permit.
3. I have a valid residential address in the Republic of Singapore.
4. I shall be present at the camping area at all times during the validity period of the permit and shall not leave the tent unattended, except during emergencies
5. I shall ensure that there is no use of open fire, LPG cylinders, portable stoves or generators of any form within or outside the tents at all times.
6. I shall ensure that the camping area is kept clean at all times and that all refuse and waste are properly removed and disposed. If I failed to do so, I shall be liable for an offence under Reg 9 of the Parks & Trees Regulations (Cap 216, Rg 1), which carries a fine of up to S\$2,000. I shall also be liable to pay costs incurred by NParks in cleaning up the camping area.
7. I agree to use the camping area at my own risk. I shall not make any claims against NParks with respect to any losses, damage or injury arising from the use of the camping area. For the same, I shall indemnify NParks against all actions, claims and demands which NParks may suffer or incur in connection with loss of life, personal injury and/or damages to property arising from or out of or in connection with the use of the camping area.
8. NParks reserves the right to remove any unattended tents and belongings, without prior notice being given to me.
